Please note a travel cost may be added if your event is more than 5 miles for Carlisle city centre, if the travel charge applies to your event this will be added to the total cost of the event and is non-negotiable

Unwarranted Abuse or threatening behaviour of any kind from client or any guests, venue management or venue staff will not be tolerated this includes any form of unsafe working environment and will result in the performance being terminated with no loss to Maddison Entertainment.

No use or touching of any Maddison Entertainments equipment is permitted unless pre-arranged with/By the person name on this form this includes audio, electrical, vehicle(s), Inflatable(s), Blower(s) or personal items, if this is found to of happened or is happening this will result in the Performance/Equipment being terminated or removed with no loss to Maddison Entertainment.

The client named on this form agrees that compensation will be paid for any loss/ damage to Maddison Entertainments equipment including Audio, Electrical, Vehicle(s), Inflatable(s), Blower(s) and personal belongings caused by client's guests, venue customers or venue staff.

Maddison Entertainment cannot be held liable for failing to attend a booking, where the reason for non-attendance or late arrival is caused by adverse weather conditions including Snow & Flooding, road closure, road traffic accident, vehicle breakdown, fuel shortages, acts of terrorism, industrial action, or other unavoidable circumstances deemed beyond our control.

The client named on this form is responsible for informing Maddison Entertainment prior to performance date, confirmation if the venue has a sound limiter installation. Please note: Maddison Entertainment reserves the right to decline entertainment services at venues with sound limiter installed if they have not been informed that one is present.

The client named on this form is responsible for ensuring that they have verified that the venue power sources are electrically safe and conform to the HSE EAW Act 1989, and amendments thereafter. Copies of venue Electrical Installation Safety Certificate (Periodic Inspection Report to NIC EIC standards) must be made available upon request by the venue under LAW.

The client named on this form agrees to provide adequate supervision of all guests and will ensure that venue management adequately supervises customers and or staff on site premises. Please note: Where the function may include guests under the age of 16 years, the client (or parent) is responsible for the behaviour and safety of any minors attending the venue. The client agrees to provide and maintain adequate adult supervision at all times. Maddison Entertainment will not be liable for the supervision of minors/any guest. Maddison Entertainment cannot and will not be held responsible for any injuries if the person is found not following the safety rules

Parking or access at venue is to be supplied for unload and load. Where the venue does not have its own parking facilities, Maddison Entertainment reserves the right to pass on any additional parking fees for refund on the night by the client. Please note: that in accordance with Health and Safety laws, Maddison Entertainment will refuse to work at venues where illegal or hazardous parking is required in order to load/ unload vehicle. This also applies to general health and safety concerns within the venue such as navigating cluttered or unlit stairways and exits.

Maddison Entertainment reserve the right on any event inside or outside to refuse the use of any Maddison Entertainments equipment including any inflatables or audio if it is deemed to be unsafe to work or leave said equipment. This includes poor weather conditions, high winds, rocky/ uneven ground, overhead obstructions, environmental risks or personal safety.

The client named on this form agrees that the confirmed entertainment date as well as start, finish times as specified on page 1 are accurate and correct. Playing times are calculated from the start of the evening and as such are not affected by clocks going back or forwards etc. Any extension beyond the confirmed finish time is at the discretion of Maddison Entertainment.
