



## Face Painting Disclaimer



We are covered with Public Liability Insurance and have an enhanced CRB.

Face painting your child shall be at your risk if they are suffering from the following conditions; a runny nose, cuts and open wounds, chicken pox, cold sores, conjunctivitis, impetigo, ring worm, eczema, lice, any allergy.

We reserve the right to refuse to paint the child in the above circumstances.

### Products

Maddison Entertainment Face painting only uses the highest quality professional paints and products which are approved by the EU and USA FDA for their specialist use. They are safe, non-toxic, antibacterial and hypo-allergenic. The paints are water-based and will wash off with gentle soap & water. We use poly-glitter responsibly, which is manufactured specially for safe use on the face & body.

- **Children (and their actions) remain the responsibility of their parents or guardians at all times**
- **WE DO NOT PAINT CHILDREN UNDER 3 YEARS OLD.** Any Child under the age of 16 years old must have a parent/ Guardian present.
- Maddison Entertainment reserve the right to refuse to paint the face of any person who appears unwell or with medical conditions such as, but not limited to, cold sores, psoriasis, open wounds, broken skin, conjunctivitis or other eye infections, runny nose, infected skin, headlice. In these circumstances we are able to paint, at the artists' discretion, the arm or hand of that person.
- We take no responsibility for the welfare or safety of persons waiting to be painted. Please ensure that children waiting to be painted are supervised at all times.
- We follow a strict code of practice regarding hygiene. We clean all sponges and brushes after each event and the water is cleaned regularly throughout each event.
- To ensure that health and hygiene standards are maintained, we ask that our products remain untouched by anyone other than the members of the team. Please ensure that children are supervised at all times.
- All products used are water based and tested for use on the skin. They comply with FDA and EU regulations. However, please note that all cosmetics can, on rare occasions, cause allergic reactions and we accept no liability for this.
- If the person to be painted has not been painted before or has sensitive skin, it is possible that face painting may cause irritation. Please therefore ask for a patch test. If there is no reaction after 15 minutes, the person may be painted. It is your responsibility to advise us of any sensitivity prior to painting and we accept no liability for irritation caused.



- We will paint at the artists' discretion the face of children who in the artists opinion are under 3 years of age, or unlikely to sit to be painted. However, in these cases the arm or hand may be painted upon request.
- At private events/parties, it is the responsibility of the organiser to ensure that the permission of parents/guardians is obtained prior to children being painted.
- Maddison Entertainment reserve the right to refuse face painting for any reason.
- Face paints are easily removed with soap and water. Baby wipes are not recommended as these may cause allergic reactions when used on the face.
- Some paints may leave a slight tint on the skin which should fade in a day or so.
- All paints used are water-based and as such should not stain clothing. However, we will not be held liable for any damage to clothing or property. Should this occur please cold soak the item prior to washing.
- Photographs will not be used without parental/guardian consent. Any photographs taken will be used for promotional purposes only and identities will not be revealed to third parties. A complimentary copy can be emailed to the parent/guardian upon request.
- We will not paint any person (regardless of age) against their wishes – including sleeping children.
- We will not paint anything that the artist deems to be offensive, obscene and/or inappropriate for the event or group.
- Please do not eat or drink whilst being painted.
- Verbal or physical abuse will not be tolerated and if this is found to be happening you will be asked to leave the area.
- All persons wishing to be painted must be presented with a clean, dry face.
- Once the queue has been closed, no-one else will be painted.

Maddison Entertainment will not be held liable for any child or adult that reacts to face paints and likewise make up products.

A Signature must be obtained for each child from the parent / Guardian to agree that the child can be painted. Maddison Entertainment will not paint a child that hasn't had the permission signed. Sorry for any inconvenience this may cause.

#### PHOTOGRAPHS

Maddison Entertainment do not take photograph/s without the consent of the person/parent/guardian. We may ask for consent to take a photograph once you/your child is painted for use in advertising (including, but not limited to, cards, press releases, flyers, website, Facebook etc). You are under no obligation to give consent.
